The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria. 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

5. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro. Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in

this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 <u>OM No.1 4 2021 PPD dated 18.05.2023</u> for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Introduction

- 1.1. The Indian National Centre for Ocean Information Services (INCOIS), Hyderabad, an autonomous body under Ministry of Earth Sciences (MoES), Govt. of India is engaged in providing ocean information and advisory services. INCOIS deals with the projects related to tsunami early warning system, ocean state forecast, ocean observing systems, ocean modelling, satellite oceanography, coastal geospatial applications, ocean data and information management and web-based services relevant to societal needs.
- 1.2. INCOIS has an operational VSAT network with 42 VSAT terminals installed at A&N islands. Under the project, the Seismic and GPS observatories spread across the A&N islands have been integrated through VSAT communication (shared hub) to the data centers at Indian National Centre for Ocean Information Services (INCOIS), Hyderabad (through MPLS Links) for receiving real-time continuous ground motion data from these observatories to meet the operational activities of INCOIS.
- 1.3. All VSAT equipment (Model: Sky Edge II-C Gemini, Make: M/s Gilat) were supplied and installed during 2021-22 and is presently covered under Comprehensive AMC. Presently, the shared hub service provider (M/s Nelco, Mumbai) is receiving data from 42 observatories and is being re-transmitted simultaneously to the INCOIS, Hyderabad through 4Mbps terrestrial MPLS connectivity (in redundancy). The existing MPLS connectivity is with M/s Airtel Ltd. and the redundant MPLS link is with M/s Tata communications Ltd. The existing VSAT equipment list at the sites as per Annexure-I-C. #### 5. Technical Terms and Conditions:

- Ensuring the uptime of the VSAT station, continuous and near real-time data reception at INCOIS. The Mean Time to Repair (MTTR) for field/remote VSAT stations from the time of reporting is 10 days for North & Middle Andaman stations and 20 days for Nicobar Islands.
- Bidder is responsible for obtaining required licenses from DoT / WPC / SACFA / NOCC / other regulatory authorities for the operations / migration of VSAT network under this contract.
- The complete VSAT network should operate in a shared-Hub, extended-C band with dedicated closed user group (CUG) satellite bandwidth of 1300Kbps (including IN and OUT bound) from Indian satellite, for online transfer of data from field stations to the shared hub. The data latency between the field station & INCOIS data center should be less than 03 seconds. The Inbound and outbound bandwidth may vary as per the field requirement and needs to be changed on-request by INCOIS. In case, the satellite is to be
